Cookies are a small piece of text sent to your browser by the website you visit on your computer or mobile device and help it remember information about your visit (for example, your preferred language and other settings). Thanks to cookies, you will have a better and personalized customer experience on your next visit.

This Cookie Notification Text aims to inform you about what kind of cookies we use for what purposes and how you can manage these cookies with regards to processing personal data obtained automatically through the placement of cookies used on our website in your device.

For the cookies that we use on our website other than the mandatory cookies, the explicit consents of the users are obtained and the users are enabled to change their consent whenever they wish. The users are able to view the types of cookies used on our website through the cookie management panel and for all cookies other than the Mandatory Cookies, they are able to determine their preferences with “on” or “off” options. The users can always change their preferences via this panel.

### A. Legal Causes and Purposes as to Why We Process Your Personal Data

Deniz Invest uses the information it collects through cookies in accordance with Deniz Invest Personal Data Protection Law Policy.

By continuing to visit our site, you allow cookies to be placed on your device. If you do not want it to place cookies on your device, you can refuse the use of cookies in your browser's settings or options. In order to have the best experience on your website visit, we recommend that you do not refuse the use of cookies. Deniz Invest may change its Cookie Policy when it deems necessary.

Deniz Invest uses 2 types of cookies:

### **1. Mandatory Cookies:**

Required and important cookies. It allows you to create a user account, log in and browse our website. Persistent cookies remain on your computer or mobile device after you close the browser or application and are used to recognize you when you return to our website. Your personal data collected through these cookies is processed in clause (c) of paragraph (2) of Article 5 of the Law, "*Provided that it is directly related to the establishment or execution of a contract, it is necessary to process personal data of the parties to the contract*" or clause (f) "*It is processed within the scope of "data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the person concerned."*

### **2. Performance and Analysis Cookies:**

These cookies are used so that websites and applications can provide you with a better, faster and safer use. With this type of cookie, you can improve and personalize the customer experience. The data obtained includes the pages accessed, the redirects, the platform type of the person accessing, the date/time information, the search terms and other texts entered during session. Your personal data collected through these cookies are processed by obtaining your explicit consent within the scope of the subparagraph 1 of the article 5 of the Law. You can manage such cookies using the cookie management panel. However, without these cookies, we cannot learn how our website is performing and make relevant improvements to improve your browsing experience.

<b>Jetlink-Visitor-UserChatId</b>	User's ChatId is kept.	Performance and Analysis Cookies	30 Days
<b>Jetlink-Visitor-UserId</b>	When the user sends a message, the assigned ID is kept.	Performance and Analysis Cookies	30 Days
<b>Jetlink-BalloonNotificationUrls</b>	The URL address that the user communicates with is kept.	Performance and Analysis Cookies	30 Days

<b>Jetlink-Visitor-VisitorId</b>	It is kept to recognize the user visiting the site.	Performance and Analysis Cookies	30 Days
<b>Jetlink-Visitor-SourceUserId</b>	It is kept to recognize the user visiting the site.	Performance and Analysis Cookies	30 Days

### **c. Data Owner Application Methods**

For your personal data processed through cookies used on our website, you can submit your requests under Article 11 of the Personal Data Protection Law, which is located at the link <https://www.denizyirim.com/Contact> 1. You may use the form provided when the Information Application sub-headings of the Law on Protection of Personal Data complaints are selected or through any of the following channels:

By sending your application by e-mail to [info@denizyirim.com](mailto:info@denizyirim.com), using your registered e-mail address,

By sending an e-mail to [info@denizyirim.com](mailto:info@denizyirim.com), using your personal e-mail address with secure electronic signature or mobile signature or the e-mail address you used to register our system,

Your application shall be finalized as soon as possible and within thirty (30) days at the latest, free of charge. If transactions pertaining to your request entail a separate cost, a fee may be charged from you as per the tariff stated by the Personal Data Protection Board.

### **How to Turn Off Cookies?**

If you refuse persistent or session cookies, you can continue to use the website, but you may not be able to access all functions of the website or your access may be limited.
